3. Report from the Campus Solna Action group and the Campus Solna Committee (Amelie):

- Appointment of Campus Solna Director

Three candidates will be interviewed during the afternoon. A second interview will be made 20th of February (prel. date). Formal decision will be taken by the board.

- Localization of groups at Campus Solna
- Martin Viklund has applied to become located at SciLifeLab campus Solna. More information was requested by the Campus Solna Committee: How SciLifeLab will be strengthened by the transfer and what requirements for space the group has.

- The first SciLifeLab fellows are to apply for a prolonged localization at SciLifeLab. This needs to be supported by the head of the department. Also, their benefit from being localized here as well as SciLifeLab benefit of having them should be described.
- Recruitment of KTH SciLifeLab Fellows and Professor Genomics
- Two new SciLifeLab fellows in Bioinformatics (Dept of Protein Science) and Gene Technology (Dept Gene Technology) are on their way to finalize the employment formalities.
- The ongoing recruitment of a Professor in Genomics (and director at NGI) has application deadline 31/1

4. KTH SciLifeLab group leaders (Peter)

- Peter goes through the list of the suggested 52 KTH SciLifeLab group leaders. Currently are there approximately 300 KTH-employed persons located at KTH campus Solna at SciLifeLab.
